

**PERSONNEL REPORT

RESIGNATIONS

1. It is recommended that the Board accept the voluntary early retirement request of **Ms. Kim Siberski** as an **Elementary Special Needs Teacher** at Mitchell School, effective at the close of the 2014-2015 school year. Ms. Siberski has been employed by the District for the past 33 years.
2. It is recommended that the Board accept the voluntary early retirement request of **Ms. Jody Klaver** as **Principal** at **Northwood Preschool Center**, effective at the close of the 2014-2015 school year. Ms. Klaver has been employed by the District for the past 18 years.
3. It is recommended that the Board accept the resignation of **Ms. Carrie Copley** as an **Educational Assistant** at Fellows School, effective January 30, 2015.
4. It is recommended that the Board accept the resignation of **Ms. Natalie Hashemi-Toroghi** as a **.5 fte Juvenile Court Liaison** and as **Intramural Soccer Coach** at Ames Middle School, effective January 8, 2015.
5. It is recommended that the Board **rescind** the resignation of **Mr. Tyler Lewis** as a **Mid-Shift Custodian (acting Interim Head Custodian)** at Ames High School, effective December 31, 2014. Mr. Lewis is currently on hold relative to military service assignment.

APPOINTMENTS

Teaching Staff

1. It is recommended that the Board approve the appointment of **Ms. Joy Biott** as a **Level II Special Needs Teacher** at the Beloit Campus, effective January 6, 2015. Ms. Biott will be placed on the BA +30 Lane, Step 0 and receive \$19,895 for this assignment. This is a new position funded with Special Education dollars to support increased program enrollment.

Support Staff

1. It is recommended that the Board approve the appointment of **Ms. Nancy Siguas** as a **2nd Shift Custodian** at Ames High School, effective December 16, 2014. Ms. Siguas will be working 8 hours per day for 140 days with a starting salary of \$10.95 per hour. She is replacing Ms. Bernice Valderravano.
2. It is recommended that the Board approve the appointment of **Ms. Alina Sing** as a **2nd Shift Custodian** at Ames High School, effective December 18, 2014. Ms. Sing will be working 8 hours per day for 138 days with a starting salary of \$10.95 per hour. She is replacing Ms. Cassandra Wobig.

Co-Curricular

1. It is recommended that the Board approve the appointment of **Mr. R. J. Voss** as an **Assistant Boys Basketball Coach** at Ames Middle School, effective for the 2014-2015 school year. Mr. Voss will receive \$2,030 (7% of base) for this assignment as he replaces Mr. Chris Reif.
